I understand that my employment with Sushi Boy, Inc. will be for no definite period and may be terminated at any time, with or without cause, by either Sushi Boy, Inc. or myself. Neither side shall seek recourse to a court or other authorities to appeal for revision of the arbitration award.

I shall promptly disclose and assign to Sushi Boy, Inc. all inventions, including ideas, processes and improvements, developed by the employee alone or with others, whether or not during regular work hours or on the employee's own time, (a) when such inventions relate to Sushi Boy, Inc.'s business, anticipated research or development; (b) when such inventions result from any work performed for Sushi Boy, Inc.; or (c) while using Sushi Boy, Inc.'s equipment, supplies, facilities and/or trade secret information.
7. This Application constitutes the entire at-will employment agreement between Sushi Boy, Inc. and myself. No change, modification or alteration of any term of this Application shall be valid unless made in writing and signed by a Senior Officer of Sushi Boy, Inc. This Application supersedes any and all previous arrangements and agreements, written or oral, express or implied, entered into by or between Sushi Boy, Inc. and myself. Any and all previous arrangements and agreements are hereby canceled and terminated in all respects. The statements above supersede and replace any prior understandings or discussions I have had with Sushi Boy, Inc. and set forth the complete agreement between Sushi Boy, Inc. and myself.
